# Hei Whakataki

Introduction

Te Māngai Pāho is committed to supporting the Māori media and music sectors in collectively improving the outcomes of the Maihi Karauna, the Crown's strategy for Māori language revitalisation. Our role is to promote Māori language and culture to all New Zealanders.

## Te Pūtake

Purpose

Music is everywhere in the world. It creates suspense in movies, excitement at football matches and fun with friends. It is ordinary for its presence in people's everyday lives, yet extraordinary for the way it can reflect and affect us, our ideas and our society.

Simultaneously, Aotearoa has made a positive shift in attitude toward te reo Māori, with language classes oversubscribed and more reo being spoken on air, on screen, and online than before. At the end of the 2020-21 budget year, we saw waiata reo Māori radio airplay up by 9% and streaming up by 29%.

To maintain this level of positive engagement, we need more talented artists who are willing and able to make a career out of music. The purpose of Oro Kura Roa is to support an emerging reo-focused music artist to do that.

An investment package to the value of \$90,000 (plus GST if applicable) will be made available with reservation for Te Māngai Pāho to adjust the investment according to market, and to contract independent services on behalf of the successful applicant.

This funding is aligned to all three focus areas of Te Māngai Pāho's <u>Standard of</u> <u>Performance Expectations (SPE)</u>: Audience, Creation and Capacity.

# Hātepe

#### Process

Given the significant investment, a short list of applicants will be invited to make a presentation to the panel of assessors before a final decision is made. Assessors will come from the music and reo communities.



## Te Kaupapa Matua

#### **Request for Proposals**

This RFP invites music artists to apply for Oro Kura Roa - support to the value of \$90,000.00 (before taxes) that enables an emerging artist to complete a body of work in te reo Māori that will enhance their repertoire, experience, and music career.

The applicant will need to complete their body of work within a 3-month period, during which they will receive a stipend, studio support and industry mentoring. The applicant is expected to be free of other regular professional commitments during this time.

#### Eligibility

- Applicants must be capable of writing waiata in te reo Māori.
- Applicants must have already released 2 waiata reo Māori but no more than 10 – under one performer name to a digital service platform.
- Applicants must already be members of APRA and Recorded Music.
- Applicants must not have received Waiata Tuarea funding from Te Māngai Pāho in the last 24 months.

#### Agreement

Along with Te Māngai Pāho's standard terms and conditions, applicants also agree to each of the following:

- Complete a body of work of no less than 6 waiata, ready for release in the second half of 2023.
- Follow a programme devised by Te Māngai Pāho that gives opportunities to strengthen their music sector relationships and knowledge.
- Adhere to the professional guidelines set out by Te Māngai Pāho.

#### Suitability

The ideal candidate to receive this support will already have:

- If in employment, support from their employer to pursue this opportunity.
- Support from whanau to pursue this opportunity.



• Proficiency in te reo Māori equivalent to level four of the Level Finder Examination administered by the Māori Language Commission, Te Taura Whiri, or endorsement from someone with notable reo credentials.

#### Proposal

- A clear vision for their body of work.
- Evidence of unfinished material that could be developed for the body of work.
- A demo of an unreleased waiata that could be included in the body of work.
- Personal statement sharing your character, career aspirations, experience and how you believe this opportunity will help you.

You can register at any time, and we encourage producers to register well in advance of the funding deadline. Applicants will not be able to submit proposals until all the required fields have been completed, so please do not leave completion of your application to the last minute.

You can save your application at any time throughout the process and come back to it via your dashboard prior to the deadline. Key 'compliance' information from your Registered Provider data will automatically populate your funding application.
